Dear Mr. Thallman:

On July 14, 2011, I conducted a site visit at Circle H Station to assess your compliance with the April 13, 2011, Notice of Violation. At this time, Brent Lucius told me the following: the two unknown drums behind the facility were used oil which were dumped into the used oil tank; the two white small buckets were also used oil which were dumped into the used oil tank; the drum that Brent thought was antifreeze during the March 23, 2011, investigation was actually washer fluid which was used as product; the drain/grate material which was dumped on the ground was cleaned up and placed into a white 55-gallon drum; the broken fluorescent bulb was cleaned up and placed in a bucket for recycling; all the used oil stained soil was cleaned up and placed into two drums and you built a berm around your used oil tank to contain any spills in the future. I observed that all of the above was cleaned up, containerized and labeled.

On October 5, 2011, I conducted sampling of your used oil stained soil drums and the drum with waste material generated from the cleaning of the drain/grate under the service repair area which was dumped onto the ground.

On October 26, 2011, I received analytical data via email from TestAmerica North Canton with the results of this sampling which indicates that all of these drums are a non-hazardous waste.

On March 22, 2012, I conducted another site visit. At this time you showed me the receipt from the disposal of your used oil stained drums and the drain/grate material. This material was disposed at the Sunny Farms Landfill in Fostoria, OH. In addition, you stated you will be managing your fluorescent bulbs as universal waste and will be recycling with Environmental Recycling in Bowling Green, OH. You also stated that you have had no other issues with used oil (spills, etc.).

I gave you a list of Used Oil Recyclers at this time as you stated that you may have to have some of your excess used oil picked up for recycling.


My review of this documentation reveals that Circle H Station has adequately demonstrated abatement of the violations discovered during the March 23, 2011, inspection as listed below:
