Dear Ms. Vallery:

On March 27, 2012, you accompanied Melissa Boyers and me during the Ohio Environmental Protection Agency's (Ohio EPA's) hazardous waste compliance evaluation inspection of your facility, The Advertiser Tribune (hereafter referenced as A-T) located in Tiffin, Ohio. Specifically, we inspected your facility to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC), and Chapter 3745 of the Ohio Administrative Code. Pollution prevention options were also discussed during this inspection. This letter will explain the violation found.

A-T is a newspaper printer. A-T generates fluorescent bulbs which are currently disposed of as hazardous waste (D009). You also generate a spent parts washer solvent (D001, D007, D018, D039). A-T also generates a small amount of used oil (about 1-1/2 gallons a month). Waste inks are disposed of as non-hazardous waste. You also have shop rags which are laundered off-site.

At the time of our inspection, you were operating as a conditionally exempt generator of hazardous waste. This means you generate less than 20-25 gallons of hazardous waste a month.

I found the following violation of Ohio's hazardous waste laws:

**1. OAC Rule 3745-279-22(C)(1), Used Oil Labeling:**

Containers and tanks that are holding used oil, must be labeled with the words "Used Oil".

A-T had one drum of used oil which was not properly labeled.

At the time of our inspection, you properly labeled the drum with the words "Used Oil", therefore, this violation is considered abated.


We encourage you to recycle your fluorescent lamps instead of disposing of them. I gave you a copy of Fluorescent Lamps: What You Should Know, a fact sheet with information on how to properly manage lamps as Universal Waste in the future. I also gave you a list of recyclers. Your current waste hauler may also offer this service.
