Dear Mr. Miller:

Thank you for your December 9, 2010 response to Ohio EPA's November 19, 2010 Notice of Violation letter. The documentation you submitted included: a statement indicating Keim's waste lamps are being recycled by Green Lite LLC, and waste radio batteries are being recycled by the supplier of your radio batteries; a photograph documenting that emergency information is now posted at a telephone located near the hazardous waste accumulation shed; a completed emergency equipment inspection sheet indicating emergency equipment is now inspected monthly and the inspections documented; a photograph which shows the hazardous waste satellite containers have their lids closed properly and are properly labeled; a photograph showing the new hazardous waste accumulation shed along with the now properly labeled containers being accumulated; a completed hazardous waste container accumulation area inspection sheet indicating hazardous waste containers are now inspected weekly and the inspections documented; documentation indicating the Keim will have its used oil recycled by Safety-Kleen, Inc.

My review of this documentation reveals that Keim Lumber Company has now abated all violations discovered during the October 22, 2010 inspection, as listed below.


