Dear Mr. Johnson:

On June 17, 2009, I inspected Jim White Honda's facility located at 1505 Reynolds Road in Maumee, Ohio. Jim White Honda was inspected to determine the facility's compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). My inspection included a tour of the facility as well as a review of facility records. I also helped you identify ways to prevent pollution by reducing waste Jim White Honda generates.

Jim White Honda is a full service automotive dealership which operates a service shop at the 1505 Reynolds Road location. Company records reviewed during this inspection indicate that Jim White Honda is a conditionally exempt small quantity generator of hazardous waste. Jim White Honda utilizes one parts washer which generates (D001) spent mineral spirits which is managed as hazardous waste. Jim White Honda also generates spent lead acid automotive batteries that are exchanged with new batteries by the battery wholesaler, used oil which is shipped off-site for recycling, used anti-freeze/coolant which is sent off-site for recycling, and spent fluorescent light bulbs.

I found the following violations of Ohio's hazardous waste laws. In order to correct these violations you must do the following and send me the required information **within 30 days** of your receipt of this letter:

1. **OAC Rule 3745-52-11, Hazardous Waste Determination:** "Any person who generates a waste, as defined in rule 3745-51-02 of the Administrative Code, must determine if that waste is a hazardous waste..."

Jim White Honda failed to evaluate spent fluorescent and high intensity discharge (HID) lamps prior to disposal to determine if the spent fluorescent and HID lamps are hazardous waste. Jim White Honda currently disposes of spent fluorescent and HID lamps in a solid waste dumpster.

Jim White Honda must immediately cease disposing of the fluorescent and HID lamps as non-hazardous waste until a proper waste evaluation has been completed. Fluorescent and HID lamps typically contain mercury and other heavy metals which could make them a hazardous waste. Jim White Honda has the option of handling spent fluorescent and HID lamps as hazardous waste or as universal waste. Managing hazardous waste lamps under the universal waste rules eases certain regulations imposed on generators of spent fluorescent and HID lamps.

To abate this violation, Jim White Honda must choose one of the following options and submit to Ohio EPA the requested information as documentation to demonstrate how Jim White Honda plans to properly manage the spent fluorescent and HID lamps:

**A) Disposal Option:**

Jim White Honda may manage the lamps as a hazardous waste. Jim White Honda must sample each type and brand of lamp used at the facility for Resource Conservation and Recovery Act (RCRA) metals using a Toxicity Characteristic Leaching Procedure (TCLP) test. Jim White Honda must ensure that all spent fluorescent and HID lamps that are determined to be hazardous waste are disposed of at a permitted hazardous waste disposal facility. Jim White Honda must submit all analytical results to Ohio EPA along with a description of how the spent lamps will be managed or,

**B) Recycling Option:**

Jim White Honda may manage spent fluorescent and HID lamps as universal waste. Universal waste spent fluorescent and HID lamps must be stored in a closed and labeled container. This container must be properly labeled with the wording "**Universal Waste Lamp(s)**", "**Waste Lamp(s)**", or "**Used Lamp(s)**". Jim White Honda must also track the accumulation of the spent lamps to ensure spent lamps are not stored for greater than 365 days. This can be accomplished with recycling receipts or by marking the container with the accumulation start date (the day the first lamp is placed in the container). Since no spent fluorescent and HID lamps were being stored at the facility at the time of this inspection, Jim White Honda should submit a photograph of the labeled container that will be used to store the spent fluorescent and HID lamps to me. Jim White Honda should also submit the name of the recycling facility Jim White Honda intends to use.

**The information requested in 1A or 1B should be submitted to my attention at the Ohio EPA within 30 days of receipt of this letter.**

Ohio EPA recommends that spent lamps be managed as a universal waste and recycled.

I have enclosed the following fact sheets on spent lamps: Universal Waste Rules for Handlers of Lamps, dated June 2005; Fluorescent Lamps: What You Should Know, dated January 2007; and Computer, Fluorescent Lamp and Ballast Recyclers, dated April 2008 for your use.

Ohio EPA will issue an EPA ID number to track my inspection activity at Jim White Honda. Jim White Honda cannot use this number for manifesting hazardous waste shipments. If Jim White Honda wants to use an EPA ID number for manifesting or other hazardous waste, used oil or universal waste activities, Jim White Honda must complete and submit a Notification of Regulated Waste Activity form (EPA Form 9029 (Rev. 11/2002) to Ohio EPA. This form is available at [www.epa.state.oh.us/dhwm/notiform.html](http://www.epa.state.oh.us/dhwm/notiform.html) or Jim White Honda can call me at the number listed below or the Division of Hazardous Waste Management, Central Office, RIS at 614-644-2977 and we will mail you a copy.

As we discussed during the inspection, you may be able to reduce the waste your company generates. If you find ways to recycle, reduce or eliminate the amount of waste that your company generates you may be able to reduce treatment and disposal costs as well as regulatory requirements. During the inspection, we observed potential pollution prevention (P2) opportunities associated with your operations. In addition to recycling the HID and fluorescent lamps, P2 options that you may want to evaluate for these operations include purchasing a used oil burner to heat your service area. Your records indicate that Jim White Honda ships approximately 500 gallons of used oil off-site per month. The installation of one or two used oil burners in your service area could reduce your costs to heat your building and ship the used oil off-site. In addition, another P2 opportunity I observed is the substitution of a water based solvent for the mineral spirits based parts washer solvent.


