Dear Mr. Lonneman:

Thank you for your December 15, 2011, response to Ohio EPA, Notice of Violation letters dated April 6, 2011. The letter you submitted included documentation for training sessions held on July 19, 2011 at VEI. Upon review of the training documentation, Ohio EPA requested training for an employee that works in receipt control that was not trained during the July 19, 2011 training session. Additional training was provided on January 25, 2012, and documentation was submitted to Ohio EPA. The training sessions were held in response to two separate letters as outlined below.

The first training session was held in response to my review of paperwork on December 23, 2010. The training covered procedures for creating new manifests for rejected loads.

The second training session was held in response to my paperwork review on February 23, 2011. The training was held to clarify the procedures for service request numbers and waste profile numbers to ensure waste receipt procedures are for the proper profile.

My review of this documentation reveals that VEI has now abated all violations discovered during the December 23, 2010 and February 23, 2011 paperwork reviews as listed below.
