Subject: Failure to Monitor Drinking Water

IRBW Properties, Ltd. dba Willard MHP is in violation of Ohio Administrative Code Rule (OAC) 3745-81-24 for failing to monitor your drinking water during the First Quarter of 2012 monitoring period and/or report results for the following contaminants: TOTAL TRIHALOMETHANES (TTHM), HALOACETIC ACIDS, FIVE (HAA5).

In order to return to compliance, IRBW Properties, Ltd. dba Willard MHP must take the following actions:

1. Immediately collect a sample of your drinking water from the maximum residence time (location in the systems where the age of the water is the oldest).
2. Submit the sample for analysis to a certified laboratory on the enclosed list.
3. Notify your customers using the enclosed instructions and public notice.
4. Complete and return the enclosed verification form to this office.
