Dear Mr. Oliver:

On May 23, 2012, Karen Nesbit and I of the Ohio EPA's Division of Materials and Waste Management conducted a site visit at your property located at 2414 3rd Street SE, Canton, Ohio. The purpose of our visit was to verify that the violations noted during Ohio EPA's June 2, 2010 complaint investigation had been addressed, and clean-up had been completed. Notice of violation letters dated July 20, 2010, September 30, 2010 and February 18, 2011, listed the violations that had been observed.

We walked around the property with you and noted that it had been cleaned up since the June 2, 2010 site visit. The piles of scrap tires have been removed, used oil is now being stored in containers located indoors, and the piles of rubbish are gone. The area along the driveway by the back garage that had been heavily stained by used oil had been cleaned up. Other areas of used oil stained soil have also been removed.

The following violation was observed June 2, 2010 and during the May 23, 2012 site visit:

- 1. Ohio Administrative Code (OAC) 3745-279-22(C)(1); Containers and above ground tanks that are used to store used oil must be labeled with the words, "Used Oil".**

Three containers of used oil were not labeled with the words used oil. This violation was abated at the time of the inspection when you labeled the drums "Used Oil". No further action is required by you.

- 2. OAC 3745-279-22(D); Generator must respond to used oil releases and perform cleanup steps.**

During the June 2, 2010 site visit we observed areas of gravel/soil along the driveway by the back garage which were heavily stained with what appeared to be used oil. We noted that there were no longer any areas of soil stained with used oil. This violation has been abated and no further action is required by you.


