Dear Mr. Patrie,

This letter is regarding the fourth quarter, 2010, CEMS Report submitted by the Canton Refinery dated January 30, 2011. The report identified the sulfur dioxide (SO<sub>2</sub>) monitor, DuPont 460 serial #C041817, for the sulfur recovery plant thermal oxidizer (Ohio EPA emission units P011 and P016) had 5.43% downtime, excluding quality assurance calibrations, for the total quarterly hours of operation. Please be aware that future operation with greater than five percent monitor downtime and/or excess emissions may result in a Notice of Violation.


