Notice of Violation

Dear Mr. Mangen:

You are hereby notified that the Ohio Environmental Protection Agency (Ohio EPA) finds you to be in violation of Ohio open burning regulations. On May 18, 2012, it was determined that open burning of solid waste had occurred on your property at 4141 State Route 48, Russia, Ohio.

The violations that have been committed include, but are not limited to the following:

- The use of open burning for waste disposal purposes.

The above identified activity is in violation of Ohio Administrative Code (OAC) Rule 3745-19-04; *Open burning in unrestricted areas*, and Ohio Revised Code (ORC) Section 3704.03. In addition, the open burning of solid waste is in violation of OAC Rule 3745-27-05(B) and ORC Section 3734.03.

You must cease all illegal open burning.

Any subsequent violations will be referred to our central office for enforcement action with the recommendation for a significant monetary penalty. Ohio EPA reserves the right, pursuant to Chapters 3704, 3714, 3734, 3745 and 3750 of the Ohio Revised Code and any other applicable state or federal laws or regulations, to seek civil and/or criminal action, reimbursement of response costs and any other appropriate legal or equitable relief for any violation of law.


