RE: Notice of Violation (NOV-HPF) for MCI Service Parts, Inc. (0303000098) based on August 1, 2007, inspection with response due by September 14, 2007.

Dear Mr. Roth:

This letter shall serve as a follow-up to the inspection conducted on August 1, 2007, of the above referenced facility by Andrea Chapman, Carol Norman and myself. The purpose of this inspection was to determine the compliance status of all air contaminant sources located at the facility.

Based on our discussions, my observations during the inspection and a review of the company's files, my findings are as follows:

1. MCI Service Parts, Inc. was issued Permit to Install (PTI) 03-16199 on December 14, 2006, for emissions units K001, K002, K003, L002, R001 and R005. It was determined during the inspection that while the company is keeping detailed records of its coating usage, coating emissions and HAP emissions, the records were not set-up according to the PTI. Since the inspection, the company's recordkeeping format has been changed and determined to be acceptable.
2. A review of the agency's file for the above mentioned emissions units shows that MCI Service Parts, Inc. has not submitted Permit to Operate (PTO) applications for these emissions units. Failure to apply for PTOs is a violation of OAC rule 3745-35-02 and ORC 3704.05.

All other emissions sources appear to be in compliance with air pollution control regulations of the Ohio EPA at this time.

At this time, NWDO requests that MCI Service Parts, Inc. submit PTO applications no later than **September 14, 2007** to correct the violation.
