Dear Mr. Moskey:

On May 23, 2012, Erika Jackson and I inspected Bob's Auto Body Sales, Inc. in St. Clairsville, Ohio to determine Bob's Auto Body Sales, Inc.'s compliance with Ohio's hazardous waste laws as found in Chapter 3734. of the Ohio Revised Code (ORC) and Chapter 3745. of the Ohio Administrative Code (OAC). During the inspection we also helped you identify ways to prevent pollution by reducing waste.

This letter will explain the violation I found, and what you need to do to correct the violation. I found the following violation of Ohio's hazardous waste law:


1. **Used oil storage requirements for generators, OAC rule 3745-279-22(C)(1):** Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

The used oil container was not labeled as required above. During the inspection however, the container was labeled therefore this violation has been abated. No further action is required.
