Dear Mr. Uchida:

The purpose of this letter is to summarize the violations for the injection molding and product cooling line, emission unit P001, and pneumatic material conveyance/storage system, emission unit P002, located at the above referenced facility. To date, the facility has not submitted quarterly deviations reports for P001 for all quarters of 2004, 2005 and 2006 and the first quarter of 2007 as required by Permit to Install (PTI) #03-13168. This is a violation of term and condition D.1 of PTI #03-13168 and Ohio Revised Code (ORC) 3704.05. In addition, the facility has not submitted semi-annual reports for 2004, 2005 and 2006 as required by PTI #03-13168. This is a violation of term and condition D.1 of PTI #03-13168 and ORC 3704.05.

This office is requesting that the company submit a written response to this letter which includes, at a minimum, the following information: (1) the quarterly deviation reports for P001 for 2004, 2005 and 2006 and the first quarter 2007; (2) the semi-annual reports for P002 for 2004, 2005 and 2006. The company should submit the requested information by **May 30, 2007**.

Please note that the submission of the requested information to respond to this letter does not constitute waiver of the Ohio EPA's authority to seek civil penalties pursuant to ORC section 3704.06.
