Subject: Notice of Violation (NOV) for failure to submit annual/quarterly deviation reports

Dear Mr. Bischoff:

Area Rock, LLC (Area Rock) was issued two Permits to Install (PTI's) in 2004 for operations at the Woodville facility. PTI 03-16087 was issued on February 10, and covered emissions units F001 (mineral extraction) and F001 (unpaved roadways and parking areas). PTI 03-16141 was issued on August 12, and covered emissions units F003 (aggregate processing operations), F004 (storage piles) and P001-P002 (2- 537 HP diesel fired generators). Each of the emissions units in these permits have deviation reporting requirements associated with them which are to be submitted to the Northwest District Office (NWDO) on an annual and/or quarterly basis, or within 30 days of some specified deviations.

To date, the NWDO has not received any reports from Area Rock since April 25, 2007. The last reports submitted covered a time period from January 1, 2007 through March 31, 2007 (1<sup>st</sup> quarter 2007). Failure to submit the required reports is a violation of the terms and conditions of the PTI's and ORC 3704.05. In order to resolve this violation, the company must submit all past due reports no later than February 29, 2008.

The submission of information to respond to this letter does not constitute a waiver of Ohio EPA's authority to seek civil penalties pursuant to ORC section 3704.06. The Ohio EPA will make the decision on whether to pursue or decline to pursue such penalties regarding this matter at a later date.
