Subject: Notice of Violation (NOV) for failure to submit annual/quarterly deviation reports


Dear Mr. Bischoff:

Woodville Enterprise, LLC (WE) was issued two permits to operate (PTO's) on March 12, 2007 for facility roadways and storage piles and permit to install (PTI) 03-17296 on April 12, 2007 for aggregate processing and mineral extraction operations. Each of the above mentioned permits have reporting requirements associated with them and since their issuance, the Northwest District Office (NWDO) has yet to receive any reports for these emissions units.

Failure to submit the required reports is a violation of the terms and conditions of the permits and ORC 3704.05. In order to resolve this violation, the company must submit all past due reports no later than **March 6, 2008**.

The submission of information to respond to this letter does not constitute a waiver of Ohio EPA's authority to seek civil penalties pursuant to ORC section 3704.06. The Ohio EPA will make the decision on whether to pursue or decline to pursue such penalties regarding this matter at a later date.
