Dear Mr. Mykytuk:

This letter shall serve as follow-up to the inspection conducted on July 16, 2007, of the above-referenced facility by this writer. The purpose of this inspection was to determine the compliance status of all air contaminant emissions units located there.

Based on our discussions, my observations during the inspection, and a review of the company's files, my findings are as follows:

Per Part II of the Specific Facility Terms and Conditions, Section A.6, an annual report is required to be submitted which summaries the actual emissions at the facility. To date, the 2006 calendar year report has not been received. This is a violation of the terms and conditions of the Title V Permit-to-Operate (PTO) and ORC 3704.05.

Per emissions unit K003, A.IV.3, a annual report is required to be submitted which summaries the actual emissions for emissions unit K003. To date, the 2006 calendar year report has not been received. This is a violation of the terms and conditions of the Title V Permit-to-Operate (PTO) and ORC 3704.05.

As discussed over the phone, even if there are no emissions for a specific emissions unit, a report must be submitted certifying that there were no emissions for that unit. In the future, submitting one annual report with the facility wide actual emissions as well as the actual emissions for K003 would satisfy both reporting requirements. The past reports must be submitted to Ohio EPA within 30 days. Future reports must be submitted to Ohio EPA by January 31st, for the proceeding calendar year.

Please be advised that this letter does not constitute waiver of the Ohio EPA's authority to seek civil penalties pursuant to ORC section 3704.06. The Ohio EPA will make a decision on whether to pursue or decline to pursue such penalties regarding this matter at a later date.
