Dear Mr. Weiker:

This letter shall serve as a formal warning that a permit application is required to be submitted for the unpaved roadways/parking areas at the above mentioned facility. This letter shall also serve as a follow-up to the complaints that have been received by the Northwest District Office (NWDO) Division of Air Pollution Control (DAPC) regarding Chambers Leasing Systems. The first fugitive dust complaint received this year was on March 6<sup>th</sup>. The second complaint was received on May 20<sup>th</sup>. Each of these complaints were investigated shortly thereafter by two separate Ohio EPA inspectors and were determined to be justified complaints.

As a result of the first complaint, emission calculations were requested of the facility to determine the emissions from the unpaved roadways/parking areas. Consequently, the facility did submit emission calculations that indicate the unpaved roadways/parking areas do not qualify for the "de minimis" exemption as provided in OAC rule 3745-15-05(B). On March 30, 2009, via electronic correspondence, the facility was then requested to submit a complete permit application for the emission unit. At this point, the application has yet to be received at the NWDO.

The Ohio EPA is requesting that the company submit the information detailed above to the NWDO by no later than June 12, 2009. In the interim, the company should immediately implement control measures to minimize fugitive dust emissions from its roadways/parking areas. Daily records of all control measures employed are to be kept and made available for review.
