Dear Mr. Hirzel:

This letter shall serve as follow-up to the inspection conducted on July 13, 2007, of the above-referenced facility by this writer. The purpose of this inspection was to determine the compliance status of all air contaminant emissions units located there.

Based on our discussions, my observations during the inspection, and a review of the company's files, my findings are as follows:

A semi-annual report is required for emissions units B004, B005, B006 and B008. The report is to indicate any exceedance of the monthly and/or rolling 12 month limitations along with the cause of the exceedance and the corrective actions to be taken to prevent further exceedances. To date, no semi-annual reports have been received for any of these emissions units. This is a violation of the terms and conditions of the terms and conditions of the Permit-to-Operate (PTO) for emissions units B004, B005 and B006 and the terms and conditions of the Permit-to-Install (PTI) for B008.


As discussed while on site, even if there is no exceedance, a report must be submitted certifying that there were no exceedances. The past reports must be submitted to Ohio EPA within 30 days. Future reports must be submitted to Ohio EPA by January 15th and July 15th, for the proceeding six months.

Please be advised that this letter does not constitute waiver of the Ohio EPA's authority to seek civil penalties pursuant to ORC section 3704.06. The Ohio EPA will make a decision on whether to pursue or decline to pursue such penalties regarding this matter at a later date.
