Re: Exceedance of annual limitations

Dear Mr. Dorman:

This letter shall serve as notification of the company's violation of annual production and emission limitations stated in Permit to Install (PTI) #03-17146 issued final on December 14, 2006. The company is considered in violation of the operational restrictions indicated in PTI #03-17146 for both the truck loading and truck receiving throughputs. These grain throughput rates were used to establish mass emission limitations in the PTI.

The annual report required by the PTI was received on January 29, 2008. The report demonstrates the company's violation of two annual operational limitations. The report indicates that the actual annual truck loading throughput was 28,983 tons whereas the limit in the PTI is 25,854 tons. It also indicates a violation of the annual receiving throughput since the actual throughput was 49,119 tons of grain but the grain limitations is 48,834 tons.

The company is required to submit a permit modification by no later than September 26, 2008. Please be advised that the submission of the requested information to respond to this letter does not constitute waiver of the Ohio EPA's authority to seek civil penalties pursuant to ORC section 3704.06. The Ohio EPA will make a decision on whether to pursue or decline to pursue such penalties regarding this matter at a later date.
