Ford Lima Plant-1155 Bible Road, Lima, Ohio

Dear Mr. Best:

The Ohio Environmental Protection Agency (EPA), Northwest District Office (NWDO) received notification on June 27, 2011, for asbestos abatement at Ford Lima Engine located at 1155 Bible Road, Lima, Ohio. On July 19 and July 20, 2011, Ohio EPA inspected the Ford Lima Engine site to determine compliance with U.S. EPA's National Emission Standard for Hazardous Air Pollutants (NESHAP) for asbestos and Ohio's air pollution control regulations adopted under Chapter 3745-20 of the Ohio Administrative Code (OAC).

Ohio EPA's inspection of the Ford Lima Engine site found friable pipe insulation being removed with glove bags. The friable pipe insulation in the glove bags was found not to be adequately wet.

This Notice of Violation letter is being issued for the following rule violation:

1. Violation OAC Rule 3745-20-05, "Standard for asbestos waste handling," for failure to maintain adequately wet asbestos-containing waste material.

Ohio EPA visited the site on July 20, 2011, and all the bags (approximately 120 bags) of asbestos-containing material had been opened up and re-wetted. Also, Rand environmental brought in garden hoses with sprayers to keep the friable pipe insulation wet during removal.

NWDO is requesting the company submit a written response to this letter by August 10, 2011, which includes confirmation of the company's understanding of the standards for asbestos waste handling.
