Subject: Failure to Monitor Drinking Water

Vizmeg Landscape Inc PWS is in violation of Ohio Administrative Code Rule (OAC) 3745-81-24 for failing to monitor your drinking water during the Fourth Quarter of 2009 monitoring period and/or report results for the following contaminants: VOLATILE ORGANIC CHEMICALS (VOC).

In order to return to compliance, Vizmeg Landscape Inc PWS must take the following actions:

1. Immediately collect a sample of your drinking water from the entry point (first tap after treatment).
2. Submit the sample for analysis to a certified laboratory on the enclosed list.
3. Notify your customers using the enclosed instructions and public notice.
4. Complete and return the enclosed verification form to this office.

Your prompt attention to this matter is greatly appreciated. Continued noncompliance may lead to enforcement actions. If you have any questions, or if the required sample analysis was performed, please call me at (614) 644-2752.

DRINKING WATER NOTICE

Monitoring requirements not met for Vizmeg Landscape Inc PWS

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During the Fourth Quarter of 2009 time period we did not monitor for the following contaminants and therefore cannot be sure of the quality of our drinking water during that time: VOLATILE ORGANIC CHEMICALS (VOC).

What Should I Do?
