Dear Mr. Hirschfield:

This letter serves as notice of violation for failure to submit your Discharge Monitoring Reports (DMR) for June, July, August, and September 2008. All DMR data must be submitted to Ohio EPA by the 15th day of the following month for paper copy submission or by the 20th day of the following month for electronic submission. Submit the missing reports within 10 days of the date of this letter.

Please be advised that failure to comply with the effluent limitations and/or monitoring requirements, including adequate laboratory controls, appropriate quality assurance procedures, and records retention, as specified in your Part III-General conditions of your NPDES permit may be cause for enforcement action pursuant to Ohio Revised Code, Chapter 6111. If these violations continue to occur and if satisfactory progress is not made, it may be necessary to initiate enforcement action to achieve compliance.

The Ohio EPA strongly encourages pollution prevention as the preferred approach for waste management. The first priority of pollution prevention is to eliminate the generation of wastes and pollutants at the source (source reduction). For those wastes or pollutants that are generated, the second priority is to recycle or reuse them in an environmentally sound manner. You can benefit economically, help preserve the environment, and improve your public image by implementing pollution prevention programs.
