Actions Required As A Result of the Above Violation	
Step 1	<p>Within 30 days issue the attached public notice of the violation in accordance with rule 3745-81-32 of the Ohio Administrative Code by the following methods:</p> <ol style="list-style-type: none"> 1. mail or other direct delivery to each customer receiving a bill and to other service connections; and 2. if necessary, the system must also use any other method reasonably calculated to reach all persons served by the water system. <p>Note: Systems opting to include the required public notice in the next water bill have up to 90 days.</p> <p>The language in italics on the attached public notice is mandatory and must be included as written.</p>
Step 2	<p>Within ten (10) days of completing Step 1 above, fill out the attached verification form and send along with a copy of the public notification issued to the Southwest District Office of the Ohio EPA.</p>

DRINKING WATER NOTICE

Monitoring requirements were not met for Crouse MHP

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During June 2008, we "did not monitor or test" or "did not complete all monitoring or testing" for total coliform bacteria, and therefore cannot be sure of the quality of your drinking water during that time.

What Should I Do?

- *There is nothing you need to do at this time. You do not need to boil your water or take other corrective action.*
- *This notice is to inform you that Crouse MHP did not monitor and report results for the presence of total coliform bacteria in the public drinking water system during the June 2008 time period, as required by the Ohio Environmental Protection Agency.*

What is being done?

Upon being notified of this violation, the water supply was required to have the drinking water analyzed for the above mentioned parameters. The water supplier will take steps to ensure that adequate monitoring will be performed in the future.

PUBLIC NOTICE INSTRUCTIONS AND VERIFICATION FORM FOR COMMUNITY PUBLIC WATER SYSTEMS WITH TIER 3 VIOLATIONS

The owner or operator of a community public water system with a Tier 3 violation or situation shall notify the persons served by the public water system as soon as practical but **no later than one year** after the system learns of the violation. At a minimum, community public water systems must issue the notice by **mail or other direct delivery**. Public notice issued by methods other than posting shall be repeated annually as long as the violation or situation persists.
