Dear Mr. Cottrell:

On September 14, 2009, I completed a review of the financial assurance documentation file for Environmental Recycling, Inc.'s (ERI) facility referenced above. I evaluated your facility for compliance with financial assurance and liability requirements set forth in the Ohio Administrative Code (OAC) rules 3745-55-42, 3745-55-43 and 3745-55-47.

In a March 25, 2009 review of the financial assurance documentation for your facility referenced above I noted the following violations: **OAC 3745-55-42**, failing to provide an updated closure cost estimate; and **OAC 3745-55-43**, failing to provide financial assurance for closure. I also noted the following area of concern: **OAC 3745-55-47(A)**, your hazardous waste facility liability endorsement for third party liability coverage for sudden accidental occurrences needed to be updated.

On April 14, 2009 you submitted the following documentation: An updated closure cost estimate of \$16,913.16; a trust account statement from Key Bank for \$17,061.51; and a hazardous waste facility liability endorsement for policy No. EPC 5964080-01 with Zurich Insurance Company with an effective date of 12/13/2008 and an expiration date of 12/13/2009.

**With this submission Environmental Recycling, Inc. has returned to compliance for the violations found during my March 25, 2009 review.**


