Dear Mr. Simon:

On September 17, 2008, this office visited the above referenced wastewater treatment plant and spoke with your technical operator, Mr. Paul Header. It was discussed with Mr. Header that your NPDES permit has been expired since November 30, 2006. As you are aware, your expired NPDES permit contains a Compliance Schedule which indicates that your wastewater treatment plant was to be totally abandoned and connected to the existing public sanitary sewers on Aberth Drive by November 30, 1996.

This letter serves as a formal notice that you are in violation of the Compliance Schedule in your NPDES permit. You are also in violation of Chapter 6111 of the Ohio Revised Code for discharging pollutants without a valid NPDES permit.

You are directed to contact this office at (330) 963-1151 by October 16, 2008, to set up a meeting to discuss your noncompliance. In the meantime, this office will be drafting a referral package, which will be submitted to our legal department for commencement of escalated enforcement.
