Dear Mr. Astro:

On August 1, 2012, Ohio EPA received a complaint regarding the mismanagement of battery acid, used oil, and antifreeze at the Martins Ferry, Ohio facility. The complainant alleged that these materials were being disposed of in the facility's bathroom drains. On August 6, 2012, Rich Stewart and I inspected Neubauer Truck Equipment, Inc. in Martins Ferry, Ohio to determine Neubauer Truck Equipment, Inc.'s compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). During the inspection I also helped you identify ways to prevent pollution by reducing waste. This letter will explain the violation we found and what you need to do to correct the violation.

We found the following violation of Ohio's hazardous waste laws:

1. **Used oil storage requirements for generators, OAC rule 375-279-22(C)(1):**
Containers and aboveground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

During the inspection, the used oil containers and tank were not labeled as required above. To demonstrate compliance with this rule, the containers and the tank must be labeled appropriately and photographic documentation must be sent to this office for review.

Neubauer Truck Equipment, Inc. needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. ***Within 21 days*** of receipt of this letter, Neubauer Truck Equipment, Inc. is requested to provide documentation to this office including the steps taken to abate the violations cited above. Documentation of steps taken to return to compliance includes written correspondence, updated policies, and photographs, as appropriate, and may be submitted via the postal service or electronically to melody.stewart@epa.ohio.gov.

Please be advised that violations cited above will continue until the violations have been properly abated. Failure to comply with Chapter 3734. of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. It is imperative that you return to compliance. If circumstances delay the abatement of violations, Neubauer Truck Equipment, Inc. is requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.
