Dear Mr. Karl:

On March 25, 2008, I completed a review of the financial assurance documentation file for the 9150 Group, LLC's (9150) facility referenced above. I evaluated the facility for compliance with financial assurance and liability requirements set forth in the Ohio Administrative Code (OAC) rules 3745-55-42, 3745-55-43 and 3745-55-47.

In addition I evaluated the facility for compliance with the financial assurance requirements set forth in the Consent Order, State of Ohio V. Aerosol Systems, Inc. and Flanner, Case No. CV-884-1014, Summit County Court of Common Pleas, dated July 9, 1990.

To demonstrate compliance with financial assurance and liability rules, 9150 uses a Trust Fund administered by J. P. Morgan (Account # 380660) established August 7, 1990. The value of the trust, as of February 29, 2008, was \$249,077.94. No other current closure financial documentation for the above referenced facility has been received by the Ohio EPA.

Upon review of the financial assurance documentation, the following violations were found:


OAC 3745-66-42 (A) requires that the owner or operator must have a detailed written estimate, in current dollars, of the cost of closing the facility in accordance with the requirements in rules 3745-55-11 to 3745-55-15 of the Administrative Code **OAC 3745-66-42(B)** and Consent Order paragraph 5(b) require written updates for inflation of the closure costs within the 60 days prior to the anniversary date of the financial assurance mechanism.
