This office received a complaint on June 13, 2011, concerning open burning being conducted on your property. My investigation, and that of the Defiance County Health Department, shows metal wire, household trash and plastics have been burned for disposal on the property. This was done within 1000' of adjacent residences in an unrestricted area.

Based on these findings, there is sufficient evidence to determine that illegal open burning did occur and the complaint is justified. This is a violation of OAC rule 3745-19-04(A). A copy of the OAC rules pertaining to open burning has been enclosed for your review. A similar letter and the OAC rules are also being sent to Wanda Schwader because she, as the property owners, may be ultimately be held liable for current and future violations.


