Dear Mr. Hill:

On August 14, 2012, Wendy Miller and I conducted a compliance evaluation inspection at Century Marketing (Century) located at 12836 South Dixie Highway in Bowling Green, Ohio. We inspected Century to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). Pollution prevention options were also discussed during this inspection. This letter will explain the violations we found and what you need to do to correct these violations.

During our visit we toured your facility and reviewed applicable paperwork. Century manufactures printed labels using water-based inks and adhesives. The digital imaging printers generate imaging oil that is recycled by Heritage Crystal Clean. Heptane is used to clean the label adhesive off of the printing rollers. The shop towels used to clean the rollers are laundered by Cintas. Waste isopropyl alcohol (D001) generated when the printing machines are cleaned is picked up by Heritage Crystal Clean for disposal. Waste water-based ink generated during a color change is sent to Envirosafe for disposal. Century has one parts washer on-site that is serviced by Heritage Crystal Clean as part of their continued use program. Spent fluorescent lamps are managed as universal waste. At the time of our inspection, Century was operating as a conditionally exempt small quantity generator of hazardous waste.

We found the following violations of Ohio's hazardous waste laws:

1. OAC Rule 3745-273-13(D)(1): Universal Waste: Fluorescent Lamp Management:

A small quantity handler of universal waste must contain any lamp in containers or packages that are structurally sound, adequate to prevent breakage, and compatible with the contents of the lamps. Such containers and packages must remain closed and must lack evidence of leakage, spillage, of damage that could cause leakage under reasonably foreseeable conditions.

Century did not store the spent fluorescent lamps in containers that were structurally sound or closed. Specifically, Century had several containers of spent fluorescent lamps in the mezzanine area that were open. In addition, Century had several spent fluorescent lamps lying on the shelves in the mezzanine area that were not properly stored in a container.

Century must contain all the spent fluorescent lamps located in the mezzanine area in containers or packages that are structurally sound and closed and submit photographic documentation to demonstrate compliance. A copy of Fluorescent Lamps: What You Should Know, was given to you at the time of our inspection. I recommend that you review this document and contact me if you have any questions.

2. OAC Rule 3745-273-14(E): Universal Waste: Fluorescent Lamp Labeling:

Each lamp or a container or package in which such lamps are contained must be labeled or marked clearly with one of the following phrases: "Universal Waste - Lamps", "Waste Lamps" or "Used Lamps".

Century did not have the containers of spent fluorescent lamps located in the mezzanine area properly labeled. In addition, Century had several spent fluorescent lamps lying on the shelves in the mezzanine area that were not properly labeled.

Century must properly label all the spent fluorescent lamps located in the mezzanine area and submit photographic documentation to demonstrate compliance.

3. OAC Rule 3745-273-16: Universal Waste Employee Training:

A small quantity handler of universal waste shall ensure that all employees are thoroughly familiar with proper waste handling and emergency procedures, relative to their responsibilities during normal facility operations and emergencies.

Century has not ensured that all employees are thoroughly familiar with proper waste handling and emergency procedures.

In order to correct this violation, Century must describe, through a training outline, how it will thoroughly familiarize (train) its universal waste fluorescent bulb handlers in proper handling and emergency procedures. Century must submit some form of documentation demonstrating that this training has been accomplished. The training must also include compliance with all rules for the handling of universal waste bulbs and the corrective actions for all violations of universal waste rules, cited above. Copies of two universal waste guidance documents were given to you at the time of our inspection. Please review this information and contact me if you have any questions.

Enclosed you will find a copy of the checklists that were completed during the inspection.


Century needs to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within **14 days** of receipt of this letter, Century is requested to provide documentation to this office including the steps taken to abate the violations cited above.

Documentation of steps taken to return to compliance includes written correspondence, updated policies, and photographs, as appropriate, and may be submitted via the postal service or electronically to melissa.boyers@epa.ohio.gov.

Please be advised that violations cited above will continue until the violations have been properly abated. Failure to comply with Chapter 3734 of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. It is imperative that you return to compliance. If circumstances delay the abatement of violations, Century is requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.
