WARNING LETTER

Dear Mr. Thompson:

On May 30, 2007, the Regional Air Pollution Control Agency (RAPCA), received a complaint regarding illegal open burning at 7905 State Route 202, Tipp City, OH. On May 31, 2007, RAPCA performed an inspection and found a large burn site approximately 6 x 6 foot which included construction debris and drywall. This burn site was within 1,000 feet of the nearest neighboring residence.

Pursuant to Ohio Administrative Code (OAC) rule and Miami County Board of Health Local (MCBHLAPCR) 3745-19-04, Open burning in unrestricted areas, the open burning of construction materials such as drywall, for the purposes of waste disposal is prohibited. Additionally, the open burning of any residential or agricultural waste for waste disposal purposes within 1,000 feet of the nearest neighboring inhabited residence is prohibited. Therefore, the open burning documented on May 31, 2007, is a violation of OAC and MCBHLAPCR rule 3745-19-04.

This letter serves as notification to you of the above mentioned violations. **Any further actions in violation of the above mentioned rules may result in an enforcement action with civil and/or criminal penalties.** If you have any questions, please contact Eileen Moran at 937-225-4004.
