**Warning Letter**

Dear Mr. Clyburn:

The Regional Air Pollution Control Agency (RAPCA) has recently been reviewing our files to determine whether or not facilities are in compliance with any reporting requirements identified in permit terms and conditions. Upon review of Parker Hannifin Corporation's files, RAPCA identified that the permit for air emissions unit P014, Wheelbrator shot peen blast operation, with baghouse control, requires quarterly deviation reports be submitted to RAPCA.

Parker Hannifin Corporation-Lewisburg plant has not submitted the required quarterly deviation reports for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> quarters as required by Permit To Install (PTI) 08-4229 issued 12/5/2000 and Permit to Operate (PTO) issued on 9/6/2002. Per Part II, D.1., of PTI 08-4229 and the PTO, quarterly deviation reports that identify all periods of time during which the pressure drop across the baghouse did not comply with the allowable range of 3 to 8 inches of water while the emissions unit is in operation shall be submitted in accordance with Part I, Section 3 of the General Terms and Conditions of the permits. If there were no deviations, a report stating "no deviations" for the specified quarter shall be submitted to RAPCA. To date, RAPCA has not received quarterly deviation reports for emissions unit P014 since 4<sup>th</sup> quarter 2005. The reports shall be submitted quarterly, by January 31 (4<sup>th</sup> quarter), April 30 (1<sup>st</sup> quarter), July 31 (2<sup>nd</sup> quarter), and October 31 (3<sup>rd</sup> quarter) of each year and shall cover the previous calendar quarters.

Parker Hannifin Corporation-Lewisburg plant is hereby notified of the failure to submit the reports identified above. The failure to submit these reports is a violation of the PTI, the PTO and Ohio Revised Code (RC) 3704.05. Parker Hannifin was informed of the reporting requirements in another Warning Letter dated December 19, 2005. Parker Hannifin shall review the records for air emissions unit P014 and submit the required reports within 14 days of receipt of this letter. The quarterly deviation reports shall cover the time period from January 1 to

October 31, 2006. In order to demonstrate that proper recordkeeping and operational restrictions are in compliance with respect to the pressure drop across the baghouse for emissions unit P014, Parker Hannifin Corporation shall submit a copy of the records that denote the actual pressure drop across the baghouse for the months of June and October 2006.
