Dear Mr. Beilharz:

The January 2007 Operational Report EPA 5002 (MOR) for Christi Water System, Inc. was received late on February 16, 2007.

Ohio Administrative Code (OAC) Rule 3745-83-01(I)(2) requires submittal of an operational report no later than the tenth of the month following the month being reported. (i.e., May's monthly operational report should be submitted to the district office not later than June 10th.)

The January 2007 MOR has Terry Beilharz listed as the Certified Operator In Responsible Charge of the water system. Mr. Beilharz's Water Distribution 1 License expired on December 31, 2006. An unlicensed operator cannot sign the MOR as being in responsible charge of the water system.


Christi Water System has been classified by the Ohio EPA as a **Class 1 Distribution** water system, not a Class A water system, as stated in our letter of February 27, 2007. Therefore, Christi Water System must hire at least a Class 1 Distribution licensed operator to be in responsible charge of the water system as required by OAC Chapter 3745-7.

Submit a copy of the contract between Christi Water System, Inc. and the certified operator who is hired to be in responsible charge of the water system to this office by March 30, 2007. The contract is to list the duties to be performed by the operator and the number of hours the operator spends at the water system weekly. (OAC Chapter 3745-7)
