SUBJECT: CCR VIOLATIONS

Dear Mr. Moyer:

The Ohio EPA - Northwest District Office (NWDO) received the 2006 Consumer Confidence Reports (CCR) for the Huron East, South, and West Districts on June 20, 2007. The CCRs were reviewed for the required content. Based on our review, these water systems are in violation of the Ohio Administrative Code (OAC) Rules 3745-96-01 through 04 for failure to comply with the CCR requirements, the following violations were noted:

1. Required health information that was required as a result of a Treatment Technique violation was not included in the reports.

"Turbidity has no health effects. However, turbidity can interfere with disinfection and provide a medium for microbial growth. Turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses and parasites that can cause symptoms such as nausea, cramps, diarrhea, and associated headaches."

2. The required water system contact person was not included.
3. An explanation of the reasons for monitoring turbidity was not included.


Be sure to correct the violations as appropriate in your next CCR. The next report for calendar year 2007 must be sent to your customers by no later than July 1, 2008. A copy of the CCR along with a Certification Form must be submitted to NWDO at the above address. Violations in future reports may result in further enforcement action.
