Notices of Violation – Monthly & Quarterly Reports

Dear Mr. Osborne:

The Grand Lake Mobile Home Park (MHP) Plant – Distribution Monthly Operation Reports (EPA Form 5002) for the June and July 2010 monitoring periods were not received by Ohio EPA – Northwest District Office (NWDO). The Total Chlorine Residual Quarterly Operating Report (EPA Form 5114) for the April – June 2010 calendar quarter was also not received by NWDO.

Ohio Administrative Code Rule 3745-83-01(I)(2) requires the operation report to be submitted to NWDO no later than the tenth of the month following the month for which the report was prepared; and also requires the report to be signed by the operator in responsible charge designated in accordance with rule 3745-7-02 of the Administrative Code.

The Division of Drinking and Ground Waters (DDAGW) has started a web-based monthly report reporting site called eDWR. It may be more convenient for you to submit the monthly reports using eDWR. More information regarding this can be obtained at <http://www.epa.ohio.gov/ddagw/reporting.aspx#edwr>.

Failure to take action to address these violations may result in enforcement action being taken.


