

SUBJECT: 2008 Consumer Confidence Report (CCR) Violations

Dear Mr. Riesen:

The Ohio EPA-Northwest District Office (NWDO) received the 2008 CCR for the Grand Lake Mobile Home Park (MHP) public water system (PWS) on June 19, 2009. The CCR was reviewed for the required content. Based on our review, the Grand Lake MHP PWS is in violation of the Ohio Administrative Code (OAC) rules 3745-96-01 through 04 for failure to comply with CCR requirements, the following violations were noted:

1. **Source water susceptibility language was not included.** Ohio EPA conducted a source water assessment of your PWS and completed a Drinking Water Source Assessment Report (SWAP) which was sent to you with our correspondence dated June 2, 2003. Proposed CCR language, which was provided in Attachment A of that letter, was to have been included in the CCR.
2. **The certification form did not have the signature of a responsible official.** Please use the enclosed certification form with the submission of your next CCR.


Be sure to correct the violations as appropriate in your next CCR. The next report for calendar year 2009 must be sent to your customers by no later than July 1, 2010. A copy of the CCR along with a Certification Form must be submitted to NWDO at the above address. Violations in future reports may result in further enforcement action.
