**NOTICE OF VIOLATION – ACTION REQUIRED**

**Subject: Failure to Sample Drinking Water for Total Coliforms as Required**

Fostoria Mobile Estates is in violation of Ohio Administrative Code (OAC), Rule 3745-81-21 for failure to comply with the total coliform monitoring.

**Monitoring Period:** November, 2008  
**Required Coliform Monitoring:** 1 Routine Sample  
**Sample Results Submitted:** No Samples Results Submitted

To ensure the safety of drinking water provided by your system monitoring for total coliforms is essential.

**ACTION REQUIRED:**

1. **Notify the people served by this water system** using one or more of the methods and the timing as required by OAC, Rule 3745-81-32 to reach all persons served. The appropriate methods for your system are listed below under the **Community** column.

Do not make changes to the public notice without consulting with the Ohio EPA beforehand.</i></p>	


2. **Complete the enclosed Verification Form within 10 days of issuing the Public Notice** and mail it to Ohio EPA - Northwest District Office. Include a copy of each notice distributed, published or posted.
3. **Collect a set of four (4) repeat samples, until one set is total coliform-negative to discontinue the Water Use Advisory.** See attached October 15, 2008 Notice of Violation letter.

**NOTE: Delivery of a Public Notice for the Water Use Advisory to each customer must be repeated every 30 days** for as long as the violation exists, unless directed otherwise by the District Office. A verification form and a copy of the public notice, stating the corrective measures completed to date, must be submitted to the Ohio EPA, Northwest District Office by December 26, 2008.

If total coliform samples were collected as required, submit the results as soon as possible. The monitoring violation would be rescinded and a reporting violation given for late submittal of the results.

# DRINKING WATER NOTICE

## Monitoring requirements were not met for Fostoria Mobile Estates

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During November 2008, we "did not monitor or test" or "did not complete all monitoring or testing" for total coliform bacteria, and therefore cannot be sure of the quality of your drinking water during that time.

### What Should I Do?

- *There is nothing you need to do at this time. You do not need to boil your water or take other corrective action.*
- *This notice is to inform you that Fostoria Mobile Estates did not monitor and report results for the presence of total coliform bacteria in the public drinking water system during the October 2008 time period, as required by the Ohio Environmental Protection Agency.*

### What is being done?

Upon being notified of this violation, the water supply was required to have the drinking water analyzed for the above mentioned parameters. The water supplier will take steps to ensure that adequate monitoring will be performed in the future.

**PUBLIC NOTICE INSTRUCTIONS AND VERIFICATION FORM FOR  
COMMUNITY PUBLIC WATER SYSTEMS WITH TIER 3 VIOLATIONS**

The owner or operator of a community public water system with a Tier 3 violation or situation shall notify the persons served by the public water system as soon as practical but **no later than one year** after the system learns of the violation. At a minimum, community public water systems must issue the notice by **mail or other direct delivery**. Public notice issued by methods other than posting shall be repeated annually as long as the violation or situation persists.
