Subject: Notice of Violation for Failure to Respond to a Significant Deficiency

This letter is notification that the Aqua Ohio Water Company - Norlick has not complied with requirements issued during this Agency's last survey performed on September 24, 2007, in violation of Ohio Administrative Code, Rule 3745-81-60. Aqua Ohio Water Company was notified in correspondence dated November 19, 2007, of the requirement to respond in writing within 45 days, with a schedule for corrective actions to address the following:

1. In accordance with Recommended Standards for Water Works Section 6.1.1 (d), the station must be "protected to prevent vandalism and entrance by animals". A mouse was visible during the survey. All vermin must be removed from the facility. Use of poisons within the well isolation radius is prohibited.
2. Currently, the sodium hypochlorite is put in portable containers at Seneca Lake and transported over to Norlick Place for use. The chemicals used at Norlick Place must be properly labeled. NSF approval is required for all chemicals used. Repackaging negates that approval.
3. Aqua Ohio must develop a backflow prevention/cross connection control program that meets the requirements of OAC Chapter 3745-95.

The water system must respond in writing within 15 days from the date of this letter with the required information. Failure to comply may result in further enforcement action.
