

**Subject: Notice of Violation for Failure to Respond to a Significant Deficiency**

This letter is notification that the Scioto Sign Company Inc Public Water System has not complied with all of the requirements issued during this Agency's last survey performed on April 22, 2009, in violation of Ohio Administrative Code (OAC) rule 3745-81-60. Correspondence dated May 13, 2009, required a written response within 45 days, with a time frame for resolving the following issues:

1. Remove and do not store in the future any toxic materials within the water treatment room. **Issue Unresolved:** Although well organized, the cleaning supplies are not to be located within the water treatment room.
2. The well cap is not designed with a downturned screened vent as required by OAC rule 3745-9-05 (P). Replace the well cap. Guidance was enclosed.
3. The Monthly Operation Reports, as required by OAC rule 3745-83-01, failed to properly report:
  - a. the maximum, minimum, and average daily plant production for the reporting period.
  - b. total hardness.

Future Monthly Operation Reports shall be completed in accordance with the enclosed instructions.

4. The Total Coliform Sample Siting Plan contained outdated contact information. Update the Total Coliform Sample Siting Plan in accordance with OAC rule 3745-81-21(Guidance enclosed).

The water system must respond in writing within 15 days from the date of this letter with the required information for all unresolved issues. Failure to comply may result in further enforcement action.
