DELINQUENCY NOTICE – ACTION REQUIRED

Subject: Failure to Sample Drinking Water for Lead and Copper as Required

Atlas Industries, Inc. is in violation of Ohio Administrative Code (OAC), Rule 3745-81-86 for failure to comply with the lead and copper monitoring requirements.

3. **To return to compliance for lead and copper**, monitor from five (5) sites between June 1 and September 30, 2010. The report is due by October 10, 2010. This will **not** appear on your 2010 Chemical Monitoring Schedule.

DRINKING WATER NOTICE

Monitoring requirements not met for Atlas Industries, Inc.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not your drinking water meets health standards. During June 1– September 30, 2009, we "did not monitor or test" or "did not complete all monitoring or testing" for lead and copper and, therefore, cannot be sure of the quality of your drinking water during that time. We did collect lead and copper samples on October 8, 2009, but this was outside the required monitoring period and could not count for compliance.

What Should I Do?

- There is nothing you need to do at this time. You do not need to boil your water or take other corrective action.
- This notice is to inform you that Atlas Industries did not monitor and report results for the presence of lead and copper in the public drinking water system during the June 1-September 30, 2009 time period, as required by the Ohio Environmental Protection Agency.

What is being done?

The water supplier will take steps to ensure that adequate monitoring will be performed in the future.
