Dear Mr. Treece:

Thank you for accompanying me during Ohio EPA's September 5, 2012, compliance evaluation inspection (CEI) of TL Service Center (TLSC) located at 1285 Industrial Drive, in Van Wert, Ohio. I inspected TLSC to determine its compliance with Ohio's hazardous waste laws as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). My inspection included observations of facility operations. This letter will explain the violations I found and what you need to do to correct the violations.

TLSC is a truck maintenance and repair facility. This site was previously operated by Conrad Trucking Inc. (OH0000566984). At the time of my inspection, TLSC was not generating hazardous waste. TLSC generates the following non-hazardous and universal wastes:

1. Used Oil: Used motor oil is accumulated in a tote and is burned in a used oil-fired space heater in the shop. The heater is less than 500,000 BTUs and is vented to the atmosphere. Oil filters are drained and then the metal is recycled.
2. Used Antifreeze: This waste is recycled through Safety-Kleen.
3. Spent Lamps: The new management at TLSC has not had spent lamps to manage yet and was not familiar with the procedure used in the past. TL Service Center plans to manage its spent lamps as a universal waste in the future.
4. Spent Parts Washer Solvent: TLSC operates one 15-gallon parts washer that is serviced by Safety-Kleen approximately twice a year. The solvent has a flash point of 150°F.

As a result of my inspection, I found the following violations of Ohio's hazardous waste laws:

**1. Used Oil Container, Labeling
OAC Rule 3745-279-22(C)(1)**

Containers, aboveground tanks, and fill pipes for underground tanks used to store used oil at generator facilities must be labeled or marked clearly with the words "Used Oil."

On September 5, 2012, I observed one tote of used oil that was not marked with the words "Used Oil". However, the tote was labeled with the words "Used Oil" during my inspection on September 5, 2012. **Therefore, this violation has been corrected.**

Please be aware that incandescent, fluorescent, metal halide, neon, high-intensity discharge, high-pressure sodium and mercury-vapor lamps could be hazardous waste when discarded. Fluorescent lamps may contain up to 40 milligrams (mg) of mercury, depending on the brand and manufacturer. Lamps may also contain lead and cadmium. Many lamps exhibit a characteristic of toxicity for heavy metals when disposed. I have enclosed copies of the following documents to assist you in properly managing your spent lamps: Fluorescent Lamps: What You Should Know and Computer, Fluorescent Lamp and Ballast Recyclers. I recommend that you review these documents carefully and contact me if you have any questions. The first document describes the rules you must follow in order to manage lamps as a universal waste.

The requirements for recycling Universal Waste lamps include:

- Prevent spent lamps from being placed into the trash;
- Place spent lamps into closed containers that are structurally sound (boxes for example);
- Label the containers with the words "Used Lamps";
- Document the length of time that the spent lamps are stored (place a date on the boxes);
- Store spent lamps for no longer than one year;
- Inform all employees with the responsibility to collect spent lamps of these requirements; and
- Ship the spent lamps to a lamp recycler (please refer to the list of recyclers that I have enclosed with this letter).

As a used oil generator you are required to store used oil in containers or aboveground tanks that are in good condition (no severe rusting, apparent structural defects or deterioration) and not leaking. Containers, aboveground tanks and fill pipes for underground tanks must be labeled with the words "Used Oil." If leaks are detected, the generator must stop the release; contain the release; clean up and manage properly the released used oil and other materials related to the release; and, if necessary, repair or replace any leaking containers or tanks prior to returning them to service. I have enclosed with this letter, copies of the following used oil fact sheets: The Regulation of Used Oil: An Overview for Ohio Businesses Who Generate Used Oil, Used Oil Burners – New Guidance for Rebuttable Presumption and Used Oil Recyclers. Please review these carefully and contact me immediately if you have any questions.

You may be able to further reduce the waste your company generates. If you find ways to recycle reduce or altogether eliminate the amount of waste that your company generates you may be able to reduce your treatment and disposal costs and you may possibly reduce your regulatory requirements. I have enclosed copies of Pollution Prevention Opportunities, a worksheet that can help you recognize opportunities for reducing waste and conserving energy at your business, and the fact sheet Management of Electronic Waste from Businesses. Please review this information and contact me if you have any questions.

I encourage you to schedule a pollution prevention assessment for your business because there are often many opportunities for businesses like yours to reduce waste and save money. If you wish to talk about an assessment or if you have other questions about pollution prevention, please feel free to contact the Office of Compliance Assistance and Pollution Prevention (OCAPP) at (614) 644-3469. There is no charge for an assessment.
