

NOTICE OF VIOLATION/RETURN TO COMPLIANCE**

Dear Mr. Martin:

On May 26, 2010, Ohio EPA performed a Compliance Evaluation Inspection (CEI) at Delphi Automotive Systems, L.L.C. (Delphi) located at 1205 North River Road, Warren, Ohio. Delphi manufactures electrical harnesses for the automotive industry and holds a valid permit with the State of Ohio in order to perform post closure activities at four closed surface impoundments. At the time of this inspection, Delphi qualified as a Conditionally Exempt Small Quantity Generator (CESQG) of hazardous waste. The purpose of this inspection was to determine Delphi's compliance with Ohio's hazardous waste laws and regulations as found under the Ohio Revised Code and Ohio Administrative Code ("ORC" and "OAC" respectively). Delphi was represented by John Martin and Dennis Rippel while Ohio EPA was represented by Karen Nesbit and me. Ohio EPA's inspection included an inspection of the Delphi facility and a review of written documentation.

Based on this inspection, Ohio EPA has determined that Delphi has violated the following state hazardous waste regulations:

1. **OAC 3745-273-14(E) Labeling/marking of Universal Waste:** *Each lamp or a container or package in which such lamps are contained must be labeled or marked clearly with one of the following phrases: "Universal Waste- Lamp(s)," or "Waste Lamp(s)," or "Used Lamp(s)."*

At least ten (10) containers of UW lamps observed by Ohio EPA were not labeled with one of the following phrases: "Universal Waste- Lamp(s)," or "Waste Lamp(s)," or "Used Lamp(s)."

Upon being informed of this violation of UW rules, Delphi immediately labeled the containers of UW lamps. Ohio EPA therefore considers this violation abated.

Ohio EPA has the following comment:

- ☞ Delphi generates a wastewater treatment (WWT) sludge from an electroplating operation which is currently managed as an F006 waste. However, based upon observations and processing information received during Ohio EPA's May 26, 2010 inspection, it appears that the WWT sludge does not meet the F006 listed hazardous waste description.

Since Delphi commingles electroplating and non-electroplating wastewaters, the resultant sludge generated from this commingled wastewater would not meet the listing description for F006 listed hazardous waste. However, Delphi recently modified the generation of the sludge by reducing the amount of water mixed with the precursor wastewaters and collected representative samples to determine if the waste was characteristically hazardous.

By letter dated May 24, 2010, Ohio EPA received analytical data and documentation from Delphi regarding samples of the wastewater filter cake sent to Test America to determine if the filter cake was characteristically hazardous for metals.

Delphi submitted three (3) representative samples to be tested using the Toxicity Characteristic Leaching Procedure (TCLP), test Method 1311 in "Test Methods for Evaluating Solid Waste; Physical/Chemical Methods," U.S. EPA Publication SW-846. The filter cake was tested for the eight RCRA metals (arsenic, barium, cadmium, chromium, lead, mercury, selenium and silver).

Analytical data submitted for the wastewater filter cake submitted to TestAmerica Laboratories on August 11, 2009 reveals the filter cake to be a non-hazardous waste. Data was submitted to this office with TCLP bench sheets and QA/QC data.

The elimination of the F006 hazardous waste stream from Delphi's hazardous waste generation reduces Delphi's generator status to Conditionally Exempt Small Quantity Generator (CESQG) at the time of this inspection.

Enclosed you will find copies of the checklists completed at the time of the inspection.

The Ohio EPA strongly encourages pollution prevention as the preferred approach for waste management. The first priority of pollution prevention is to eliminate the generation of wastes and pollutants at the source (*i.e.* source reduction). For those wastes and pollutants that are generated, the second is to recycle or reuse them in an environmentally sound manner.
