

Subject: Notice of Violation for Failure to Respond to a Significant Deficiency

This letter is notification that Wapakoneta KOA PWS public water system has not complied with requirements issued during this Agency's last survey performed on October 6, 2008, in violation of rule 3745-81-60 of the Ohio Administrative Code. In correspondence dated October 20, 2008, you were notified to respond in writing no later than 45 days, with time frames for resolving the following deficiencies:


1. The well cap was not designed with an integrated screened vent as required by OAC rule 3745-9-05 P. Replace the well cap with one which fits securely to the top of the well casing, secured with screws or other appropriate connections, and vents to the atmosphere. The vent shall be screened.
2. The drain line from the filter discharged directly into waste plumbing located in the laundry area of the office building. The drain line from all treatment equipment shall be protected by an air separation gap in accordance with the provisions of OAC chapter 3745-95. Install and maintain the appropriate air separation gap, minimum of 1", between the drain line and waste drain plumbing.

The water system must respond in writing within 15 days from the date of this letter with the required information. Failure to comply may result in further enforcement action.
