**NOTICE OF VIOLATION – ACTION REQUIRED**

**Subject: Failure to Sample Drinking Water for Total Coliform as Required**

Enterprise Baptist Church is in violation of Ohio Administrative Code (OAC), Rule 3745-81-21 for failure to comply with the total coliform monitoring requirements:

**Monitoring Period:** April – June 2008  
**Required Coliform Monitoring:** One (1) sample per quarter  
**Sample Results Submitted:** None

To ensure the safety of drinking water provided by your system monitoring for total coliforms is essential.

**ACTION REQUIRED:**

1. **Notify the people served by this water system** using one or more of the methods and the timing as required by OAC, Rule 3745-81-32 to reach all persons served. The appropriate methods for your system are listed below under the **Transient Non-Community** column.

**2. Complete the enclosed Verification Form within 10 days of issuing the Public Notice and mail it to Ohio EPA - Northwest District Office. Include a copy of each notice distributed, published or posted.**

If total coliform samples were collected as required, submit the results as soon as possible. The monitoring violation would be rescinded and a reporting violation given for late submittal of the results.
