

**Subject: Notice of Violation for Failure to Respond to a Significant Deficiency**

This letter is notification that the Christian Church Inc has not complied with requirements issued during this Agency's last survey performed on May 21, 2008, in violation of rule 3745-81-60 of the Ohio Administrative Code. The village was notified in correspondence dated June 25, 2008, to respond in writing no later than 45 days, with time frames for:

1. The system does not own or have an easement or lease of the entire property within the sanitary isolation radius for the existing well (OAC Rule 3745-9-04(A)(3)). This isolation radius is necessary to protect the well from sources of potential contamination as evidenced by the farming activity occurring within the sanitary isolation radius. Submit a plan of action establishing an alternate source of water in the event the existing source should fail.
2. The well cap is not designed with a downturned, screened vent (OAC Rule 3745-9-05 P). Replace the well cap with one that fits securely, secured with screws or other appropriate connections, and incorporates within its design downturned screened vent to the atmosphere.
3. The drain line from the water softener shall be protected against contamination by maintaining the terminal end of the drain line suspended at least 1" above the flood level of the sump basin (OAC Chapter 3745-95). Investigate the hazard and protection required on the water fill line to the water boiler heating system.

The water system must respond in writing within 15 days from the date of this letter with the required information. Failure to comply may result in further enforcement action.
