Subject: Notice of Violation for Failure to Respond to a Significant Deficiency

This letter is notification that the Shady Shore Campground has not complied with requirements issued during this Agency's last survey performed on August 2, 2011, in violation of rule 3745-81-60 of the Ohio Administrative Code. The village was notified in correspondence dated August 22, 2011, to respond in writing no later than 30 days, with time frames for:

- Provide all four (4) bolts in the well cap. Two (2) of the bolts were missing during the survey.

The water system must respond in writing within 15 days from the date of this letter with the required information. Failure to comply may result in further enforcement action.
