Re: Demolition Activities Being Conducted Without Notification, Greenhouse 12777 Mogadore St. NW

Dear Mr. Frost,

On January 8, 2009, myself and Steven Lacey, the Lake Township Zoning Administrator were once again called to this site and observed not only active demolition of a building on this site, but also an illegal open burning inside one of the structures.

This office has seen no documentation as to the exact locations of asbestos around the property and therefore has no choice but to view the entire site as asbestos-containing. The actions of the salvage crew were therefore in violation of Ohio Revised Code 3745-20-04 (A) (1):

3745-20-04 (A) Each owner or operator of a demolition or renovation operation to whom this rule applies shall comply with the following procedures: (1) Remove all regulated asbestos-containing material from a facility being demolished or renovated before any activity begins that would break up, dislodge, or similarly disturb the materials or preclude access to the materials for subsequent removal...

The regulated asbestos-containing material has not been removed from the property.

The fire inside of the building was in violation of Ohio Revised Code 3745-19-04. While open burning for warmth of outdoor workers is permitted, the Ohio EPA specifies that the fuel shall be chosen to minimize the generation and emission of air contaminants. This was not the case. The fire was very smoky as can be seen in the photographs.

This site has been the source of repeated citizen complaints and several incidents where people have been on site disturbing and removing materials. Therefore this agency requests that no further activity take place on this property until such time that the asbestos remediation has been completed and a post-inspection performed by this Agency.

Further incidents will be considered trespassing violations unless the party on site can produce written documentation of permission granted by the property owner for them to be on site. If the property owner is other than Glick Real Estate LTD, then written documentation of property ownership transfer will also be required so that the legal owner of the property can be known. 


