Thank you for your June 20, 2011, July 11, 2011, July 12, 2011, July 14, 2011, August 3, 2011, and August 12, 2011, responses to Ohio EPA's June 1, 2011, Notice of Violation letter. The documentation you submitted included photographic documentation demonstrating the labeling of the roll-off container managing F006 hazardous waste filter cake in your wastewater treatment plant, a waste profile for the disposal of the waste, and a copy of your weekly inspection checklist.

My review of this documentation reveals that Sanoh America, Inc. has now abated all violations discovered during the April 26, 2011, inspection as listed below.
