



Re: Warning Letter for Continuous Emissions Monitoring System (CEMS) Excess Emissions

Dear Mr. Patrie,

This letter is regarding the first quarter, 2011, CEMS Report submitted by the Canton Refinery dated April 30, 2011. The report identified the sulfur dioxide (SO<sub>2</sub>) monitor, DuPont 460 serial #C041817, for the sulfur recovery plant thermal oxidizer (Ohio EPA emission units P011 and P016) had 5.03% excess emissions, excluding quality assurance calibrations, for the total quarterly hours of operation. Please be aware that future operation with greater than five percent monitor downtime and/or excess emissions may result in a Notice of Violation.
