Dear Ms. Moeller:

Thank you for your May 30, 2012, response to Ohio EPA's May 29, 2012, Notice of Violation (NOV) letter. Ohio Decorative Products (ODP) submitted annual hazardous waste report documentation. Central Office's review of the documentation submitted reveals that ODP has adequately demonstrated abatement of the violation cited in the May 29, 2012, NOV.

The following is a summary of the violation cited in the May 29, 2012, NOV as a result of Ohio EPA's May 15, 2012, inspection and your compliance with respect to it:

1. OAC Rule 3745-52-41: Annual Report:

A generator who ships any hazardous waste off-site must prepare and submit to Ohio EPA the "Annual Hazardous Waste Report" by March first of each year.

ODP failed to prepare and submit the 2011 Annual Hazardous Waste Report. ODP generated large quantities of hazardous waste during 2011, and therefore should have submitted an Annual Hazardous Waste Report by March 1, 2012.

On May 30, 2012, ODP submitted an electronic 2011 Annual Hazardous Waste Report. This report was reviewed by Ms. Mary Ann Silagy, DMWM, Columbus Central Office, and found to be complete.


With this information, this violation has been abated.
