Re: Illegal Disposal of C&DD – Circleville, Ohio – Return to Compliance

Dear Mr. Gillum:

On May 7, 2012, at your request, I re-inspected the property that you own on Island Road, across from the Pickaway County Jail, just outside of Circleville, Ohio. At that time you had already removed the majority of the construction and demolition debris that had been illegally disposed of at this property. I also asked that you send me copies of disposal receipts as proof that the debris had been taken to a licensed disposal facility.

On May 22, 2012, I received faxed copies of disposal receipts for four loads of debris that was taken to the Fayette County C&DD Landfill and one of debris that was taken to the Pike Sanitation Landfill. Based on this information, you have successfully abated the notice of violation for the illegal disposal of construction and demolition debris that I had issued to you on May 3, 2012.
