Dear Sirs:

On October 2, 2012, Dave Dysle and I, with Ohio EPA's Division of Materials and Waste Management, inspected AA Sanitation located at 4637 State Road, Peninsula, Ohio. We met with Phil Yacovazzi. The purpose of this was to investigate a complaint and to determine if this facility was in compliance with Ohio's hazardous waste, solid waste, universal waste and used oil laws and rules as found in Chapter 3734 of the Ohio Revised Code (ORC) and Chapter 3745 of the Ohio Administrative Code (OAC). A separate letter will be sent regarding solid waste rules.

This site does not have an Industrial Storm Water Permit as required by the Division of Surface Water. You may want to discuss this with Phil Rhodes of Ohio EPA's Division of Surface Water. His phone number is (330) 963-1136.

The complaint alleged that AA Sanitation spills and dumps oils, paints, and other things onto the ground. We saw areas of the ground that were contaminated by what appeared to be used oil. This is cited as a violation below.

Because Mr. Yacovazzi had an appointment to go to, we could not complete the inspection. Please call me to schedule a time that we can complete the inspection.

The following violation was found:

1. **OAC Rule 3745-279-22(D) - Response to releases of used oil.**

This rule requires that upon detection of a release of used oil to the environment, the generator must clean up and manage properly the released used oil and other materials.

AA Sanitation and/or the property owner violated this rule by having what appeared to be used oil on the ground at multiple locations and especially at the back of your building. This contaminated soil/gravel must now be removed and disposed of properly. As with any waste you generate, you must determine whether this removed gravel and soil is a hazardous waste. At a minimum, it must be shipped to a solid waste landfill. Please notify me before this work is done. I may come out to see some of the work being done. You will need to be able to document that all the visible used oil contamination has been removed. Do not put down new soil or gravel until you are certain you can document that.

Especially if I am not available when the work is being done, you should photograph the cleanup and the area once all of the contamination has been removed.

I have enclosed a document that gives more information regarding used oil rules, along with two lists of local places that dispose or recycle certain wastes.

You need to immediately take the necessary measures to return to compliance with Ohio's environmental laws. Within 14 days of receipt of this letter, you are requested to provide documentation to me including the steps taken to abate the violations cited above. Such documentation may include written correspondence, updated policies, and photographs, as appropriate.


Please be advised that violations cited above will continue until the violations have been properly abated. Failure to comply with Chapter 3734 (or 3714 for C&DD) of the Ohio Revised Code and rules promulgated thereunder may result in a civil penalty of up to \$10,000 per day for each violation. If circumstances delay the abatement of violations, you are requested to submit written correspondence of the steps that will be taken by date certain to attain compliance.
